As we reflect on the vital work accomplished this year, Family Service Center remains hopeful for the future. With your support, our staff was able to provide crucial mental health care to community members, many of whom would not otherwise be able to access or afford this care. Approximately 77% of FSC's clients qualified for a reduced fee.

This report reflects FSC's increased services. Clinicians provided over 5,000 hours of therapy, completed 36 health and safety assessments, and delivered fourteen presentations to over 800 people in the community. FSC also continued to develop collaborative relationships and to expand our formal outreach and educational programming with local school districts, clubs, and places of worship.

For fiscal year 2020, we look forward to continued collaborations with supportive individuals, foundations, corporate partners, school districts, inspirational leaders, community and civic groups, and other social service agencies.

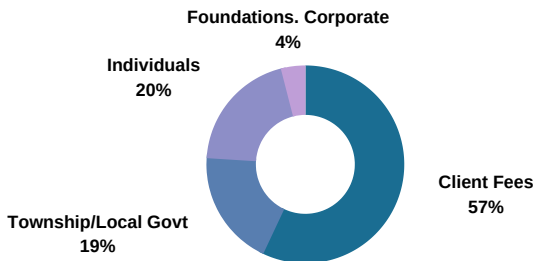

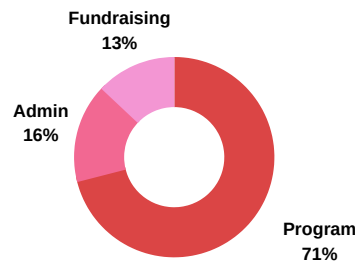

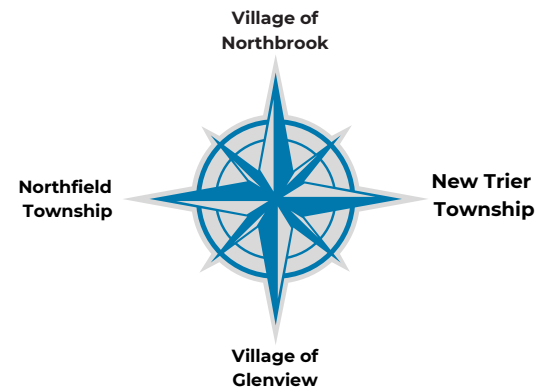
